**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

**ARP-ESSER Application – Part 1:** The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

**ARP-ESSER Application – Part 2:** The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. - not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. In June 2021, the district hosted a series of meeting with stakeholder groups, as well as utilizing parent surveys. The Assistant Superintendent met with the student counsel to gather feedback. Students generated ideas for use of funds based upon their perceived needs. Ideas were cataloged by category corresponding to ARP guidelines. Additionally, the Assistant Superintendent met with a cross-sectional group of staff, including teachers, teacher assistants, aides, maintenance, clerical, health staff, BOCES representatives and community based-organizations. As with the students, this group generated ideas based upon their perceived needs. These responses were catalogued by category corresponding to ARP guidelines. Lastly, parents were surveyed. The survey aligned with the ARP application categories. Parents were presented with both forced-choice and open ended responses. Approximately 20% of parents responded to the survey.

- 3. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

Funds have been proposed to be used to purchase appropriate PPE supplies, cleaning supplies and HVAC filters. A significant portion of the funds will be used to retain instructional staff to promote social distancing and to keep class sizes at a minimum at all grade levels.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

The district will utilize multiple measures to identify students who require after-school and summer school learning opportunities. Aimsweb, reading F& P benchmarking, SRI data, attendance, 3-8 testing data, regents score data, interim assessment data, office disciplinary referrals, teacher recommendation and classroom performance are all factored into the decision-making process.

Three times per year, each building will utilize the above information to progress monitor student's progress in interventions and on foundational skills. The elementary school will utilize Phonics First, Fontas & Pinnell LLI Kits, Handwriting without Tears and Haggerty Phonemic Awareness for reading interventions and Building Fact Fluency for Math Intervention. Aimsweb will be used three times per year to make intervention decisions. At the Middle School Level, Read 180 and System 44 will be utilized. The SRI and Aimesweb will be utilized three times per year to make intervention decisions and monitor progress. All measures will be given each fall to compare to the spring measures. This will provide data on the effectiveness of the summer learning opportunities.

- 5. The district will utilize the 20% carve-out to provide a six week summer school program available to all students, but particularly targeted to students whose data profile from question number 4 dictated it. The summer school is open to all students K-12. Additionally, there will be after-school tutoring available K-12. Again, the above criteria will be used to determine these students who will be targeted. An instructional position is being added so support remote instruction for those students who are temporarily placed in quarantine or isolation throughout the year. Funds are also being allocated for training and enhanced curriculum development for instructional staff, as well as instructional materials and classroom technology to support the program enhancements.

The district will utilize the additional funds for retention of instructional staff to enable the district to provide enhanced instruction at all grade levels, as well as to promote social distancing as referenced in item 3.

- 7. The district's plan includes braiding funds from multiple sources. In addition to providing evidence-based instruction within the classroom, the district will provide after-school tutoring and summer school. The district is using funds to update its catalog of evidence-based counseling programs, as well as implement school-wide multi-tiered systems of support for behavior. The district has hired a behavioral support specialist to aid in implementing this new system. Additionally funds were braided to purchase additional materials to support ENL and Special Education instruction. After-School learning opportunities will be provided to any student who is at-risk or is not meeting grade level learning standards. The summer learning opportunities are open to all students, regardless of academic need, however students who are at-risk or not meeting grade level standards will be scheduled first. This ensures that students from disproportionately impacted groups are prioritized.

In December 2021, the district will estimate unused funds and evaluate the effectiveness of its plan. During January of 2022, the district will again engage the same stakeholder groups to gather input on plan revisions. Revisions will be consistent with updated guidance and needs. By the end of January 2022 the new plan will be posted on the district's website. Parents will be surveyed for thier input each January and June. Additionally, students, staff and community based organizations will be met with in-person to gain input. All feedback will be considered when making revisions, with money allocated to those suggestions that are allowable and consistent with the plan's goals. This same process will be followed in each June and January for the duration of the plan period.
